# Wescliffe Homeowners' Association Agenda Annual Meeting 2 May 2017

#### Meeting to order at 7:40 p.m.

#### **Association Organization:**

- Ron welcomed and the community and reviewed the guidelines for running the meeting (revised Robert's Rules of Order)
- Jeff summarized the 12 months of the current BoT (13 meetings)
  - Finances getting organized
  - Working on the final legalities of the association (Bylaws)
  - Established Robert's Rules to ensure all voices are heard
  - Website developed for timely communications (backend database still under development)

#### **Committee Reports:**

- ACC
  - Introduction of members
  - o Forms now online for house improvements/color changes
  - Accomplishments
    - Restructured membership (5 voting members nominated, representation from all aspects of our community, etc)
    - WC1 sign installed
    - WC1 water meter (disconnected, and looking at ways to reconnect)
    - Work parties starting (to get community together and save costs)
  - Current
    - WC1 wall repair (and post caps)
    - Green belt maintenance
    - Implement new 20 yr plan
    - Continue to maintain/improve entryways
- Bylaws
  - Bylaws are required by the State...but we still do not have signed bylaws for our community (40 years later)...they have gone through multiple Boards, committees, and lawyers...but never completed.
  - O Adam's letter has been pulled out, and is now a supplement
  - O Bylaws have been sent back to the ACC, then the BoT for approval before being sent to the community for a 50% vote to approve.
- Finance (Jeff read notes from Chuck who could not attend)
  - o \$12,000 (appx) in bank with \$3,000 to deposit
  - o 40 residents have paid 2017 dues
  - 2 biggest delinquent accounts have been passed to the Wescliffe attorney for collections
    - Other delinquent accounts will be sent in the order of "amount owed."
- Nomination and Election Committee
  - New Bot announced for 2017-2018 Scott Morgan, Ron Eardley, Chuck Bowman, and Jeff Klancke (will need appoint the 5<sup>th</sup> member since only 4 people ran for election)
- Hospitality Committee
  - Working on keeping the directory up to date
  - Annual picnic will be planned
  - Checking on governing docs about posting information in the "members only" section
  - o Content needs to be completed BEFORE the Annual Meeting to show to community

Recommendation for the outgoing Bot to the incoming BoT:

- Set up separate budgets to save for future expenditures so it does not strain our tight yearly budget (for example put aside \$100 per year to replace an entry sign we know will need replacing in 20 year)
- Finalize website
- Finish the collection of dues and tighten up "due dates"
- Revise timeline for BoT actions (finalize budgets, send dues notices, etc)

#### **Resident Comments:**

- How do we get more involvement from WC2 members
  - o Keep up communications, get them on committees, annual picnic
- Members can request trees be cut below WC from the county (at their expense)
- Why aren't people paying dues
  - o Busy, forget, don't agree with something....we don't exactly know
- How long do residents get to look at the bylaws before there is a vote
  - o No time specified...we would rather get it right and give people the time they need...more info when we get closer to that point
- Can we have options for work parties
  - o Absolutely...we will work on it
