2. **Budget for 2019**: Board approved **\$9200**. budget for the ACC Breakdown: W-I Entryway Lawn Services & Pruning \$2500, Irrigation, water, testing & repairs \$1020, W-II Lawn service & landscaping \$ 1500, Miscellaneous W-I & W-II Entryways \$400, Greenbelt maintenance, planting, cutting trees, blackberries & noxious weeds \$ 3780. For a total of \$9200.00.

#### 3. Greenbelt:

- a. **Blackberry Brambles:** Brad spent one day cutting back blackberries. In certain areas they are dense. Stephanie will ask Brad if he can spend one more day cutting blackberries this year.
- b. **Planting:** 200 trees and plants have been purchased to be planted in the spring of 2019. This includes Pacific Willow, Bitter Cherry (40' tall), Cascara (30' tall), and Osier Dogwood. The growth rate of these trees is considered slow.

# 4. Entryway Maintenance

- a. **Wescliffe I** Cherry Tree Pruning Robert Sweet pruned the cherry trees Oct 15 & 16. Robert Sweet said one cherry tree has a break in its bark where termites have infested it. We will allow Robert to treat this tree and hope it improves. East to west on north side of entryway it's the 2<sup>nd</sup> cherry tree.
  - b. Wescliffe II Jason Verberne will research options to improve the entryway.
- 5. **Private Property Tree Cutting** --- Tanya asked that the ACC assist/support her in requesting that certain trees on lots be topped or taken down to protect her view rights. Tanya has spoken with Board President Scott Morgan who will address this issue of trees with her and the corresponding homeowners with a neighborly approach.
- 6. **Architectural Enhancement Requests** The deck being constructed behind Claudia Harrell's home (W-I Lot 10) was brought up as no request for approval has been turned into the ACC. Tanya will contact Claudia as any exterior changes must be approved before project begins.
