#### **Old Business:**

  passed.

- Based on the yearly schedule, Ron moved to establish a "Nomination and Election Committee" to handle the upcoming elections. Heath seconded, unanimously passed.
- Discussion revolving around the need for Wescliffe 2 to have a proper neighborhood entry led to the establishment of a "Wescliffe 2 Entrance Committee" being established. Heath moved to accept, Bruce seconded, unanimously passed.
- Roberts Rules for organizing meetings were presented. Jeff moved to accept Roberts Rules for BoD meetings and for the Annual Meetings. Heath seconded, unanimously approved.
- BoD meetings are now officially held the 3<sup>rd</sup> Tuesday of each month at 7:30. If members would like to join the meeting, they need to contact a BoD member so we can set a location that can accommodate the number of people expected.

#### **New Business:**

- Sign options for Wescliffe one were looked at, but passed back to the ACC for an official proposal. Will review once received.
- Greenbelt options and Wescliffe 1 water issue were also passed to the ACC for an official proposal. Will review once received.
