3. Greenbelt:

- a. **Tree Cutting:** I'm In! Tree cutting began on June 17 & 18. The Board approved \$5000.00 for an additional three days of cutting trees and cutting up dead logs for ground contact. This amount includes \$500.00 for trees to be planted in the valley adjacent to the Austin's property this fall.
- b. **Planting:** Robert Sweet has willows trees he has been dividing and growing for Wescliffe and will plant this fall.

4. Entryway Maintenance:

- a. **Wescliffe I landscaping** Joel will ask the Board for clear guidance on HOA "pruning and trimming" of the trees in the entryway. Both lot owners (#1 and #28) have resisted our attempts to properly repair stucco wall cracks caused by mature trees on these properties and trim/prune the cherry/crabapple trees. It appears the crack in the wall (west side Lot 28) is getting larger because of the roots of a large evergreen tree on this property.
- b. Stucco wall repair was done by Scott Morgan and Joel Postma. Stephanie and Lori will prime and paint when weather permits. Lori purchased primer and paint for this project.
- 5. **Wescliffe II** -- Jason talked to several neighbors for their opinions on updating the entryway. Stephanie and Jason will work on a landscape plan and hopefully plant this fall. Shirley Case would like to be apprised of the plan before implementation. Shirley and Jason are willing to help water new landscape plan. Joel will ask Board for \$500.00 for this project.
- 6. **Private Property Tree Cutting** --- The City of UP and Robert Sweet have become involved with the removal of these trees. Robert recommends more trees be planted to help control erosion on the slope. Joel wants to close this issue unless we have unfavorable feedback from the City of UP, neighbors or Robert Sweet.
